A RESOLUTION TO ENTER INTO A CONTRACT TO PURCHASE AND INSTALL A SPECIFIC, REPLACEMENT, STAINLESS STEEL, VARIABLE BUOYANCY, MOVABLE BULKHEAD FROM AQUATIC DEVELOPMENT GROUP, INC., AS SUBMITTED IN PROPOSAL ID 15-0909-SO1, IN AN AMOUNT NOT TO EXCEED A GRANT FROM THE TIMKEN FOUNDATION OF CANTON.

WHEREAS, the Timken Foundation of Canton awarded the Canton City School District Two Hundred Forty Thousand Dollar (\$240,000.00) grant to purchase specific items for the district's natatorium; and,

WHEREAS, a previous grant award from The Timken Foundation of Canton provided a swimming pool bulkhead that has exceeded it reasonable life expectancy; and,

WHEREAS, Aquatic Development Group, Inc., has proposed a replacement Stainless Steel variable Buoyancy Movable Bulkhead in its proposal dated September 9, 2015. [Proposal ID

15-0909-S01]. This bulkhead is fully compatible with the existing natatorium pool infrastructure and was specifically awarded funding by The Timken Foundation of Canton.

WHEREAS, pursuant to the Aquatic Development Group, Inc., April 22, 2014 initial proposal, and evaluating the August 9, 1979 and February 14, 1980 correspondence from the Whitten Corporation, due to the unique characteristics of the Aquatic Development Group, Inc., bulkhead as proposed and dated September 9, 2015, [Proposal ID 15-0909-S01]; and as further explained in Aquatic Development Group, Inc.'s September 28, 2015, correspondence, there is no other readily available competitive manufacturer for this equipment. Other competitor's equipment is either not compatible with the current natatorium infrastructure or would require such extensive reconstruction of the natatorium and pool facility as to render the entire project fiscally unfeasible. Only Aquatic Development Group, Inc., manufactures and installs the bulkhead with a 90 degree rotation to rest laterally along the swimming pool edge. Other bulkheads must move laterally along the pools edge and are neither fully "self-buoyant" nor fully compatible with the current pool infrastructure.

WHEREAS, the Timken Foundation Grant is specific to the Aquatic Development Group, Inc., replacement Stainless Steel variable Buoyancy Movable Bulkhead in its proposal dated September 9, 2015, [Proposal ID 15-0909-S01] so that there is no other viable competitive bidder for this equipment.

NOW, THEREFORE, BE IT RESOLVED, that based upon all of the information available, and applying the Sole Source Provider doctrine, the Canton City School District Board of Education, as a condition subsequent to accepting The Timken Foundation Grant agrees to enter into a contract to purchase and install the specific, replacement Stainless Steel Variable Buoyancy Movable Bulkhead from Aquatic Development Group, Inc., as submitted in Proposal ID 15-0909-S01, in an amount not to exceed the Timken Foundation Grant.

A RESOLUTION TO ENTER INTO A CONTRACT TO PURCHASE AND INSTALL AN AQUATIC TIMING / SCORING EQUIPMENT, SOFTWARE AND INSTALLATION FROM COLORADO TIMING SYSTEMS, IN AN AMOUNT NOT TO EXCEED A GRANT FROM THE TIMKEN FOUNDATION OF CANTON

WHEREAS, the natatorium has an extensive swim competition timing system that contains starting signals, and tracks and records each competitor's lap splits and overall time. The current system supplied by Colorado Timing System includes computerized, competitor touch pads, starting blocks, integrated systems and programming. One of the prime considerations for upgrading the timing and scoreboard display is to meet the standards established by the Ohio High School Athletic Association (OHSAA) that holds the Ohio State Championship swimming meets at the natatorium.

WHEREAS, Colorado Timing Systems has submitted a proposal to upgrade the current system including two full-color graphics display scoreboards at a cost of \$68,400 for equipment and installation.

WHEREAS, there is a potential competitive bidder through the Daktronics Company. However, the Daktronics scoreboards do not accept fully compatible, full capacity input from the competitor starting blocks, touch pads and integrated split and finish timing software. The Daktronics scoreboards do not meet the OHSAA minimum standards.

WHEREAS, although the scoreboards may be provided by more than one supplier, the Daktronics scoreboards will result in incompatibility with existing equipment, software and conditions. The acquisition and installation of the Colorado Timing Systems equipment will result in a savings of time, money and will reduce training and implementation of the new equipment.

WHEREAS, these factors combined with the specification of Colorado Timing Systems in the grant application, consideration and award, exempts this purchase from the stringent bidding

requirements of Revised Code section 3313.46, just the same as if The Timken Foundation had purchased the equipment and directly donated it to the Canton City School District.

NOW, THEREFORE, BE IT RESOLVED, that the Canton City School District Board of Education, as a condition subsequent to accepting The Timken Foundation Grant, hereby enter into a contract to purchase and install Colorado Timing Systems to upgrade the current natatorium timing system including two full-color graphics display scoreboards at a cost of \$68,400 for equipment and installation.

WHEREAS, there is a need to increase the quantity, as well as the quality, of substitutes teachers (substitutes) in the Canton City School District; and

WHEREAS, we have ninety-seven (97) active substitutes available to substitute in our district. Of the ninety-seven (97) substitutes on our list, twenty-three (23) are already committed to us on a daily basis for permanent, long-term assignments. Therefore, only seventy-four (74) "hypothetically" remain available, thirty-nine (39) of these are on multiple districts' lists, thus making us compete for their services; and

WHEREAS, all of the substitutes have the minimum ODE requirement of a Bachelor's degree and a substitute license, but very few have a teaching license; and

WHEREAS, we have an unfilled daily rate of approximately 21% which places an undue strain throughout the district; and

WHEREAS, we are not financially competitive with other districts in the daily rate of pay for substitute teachers; and

WHEREAS, the Canton City School District's daily rate for substitutes is \$72.00 which has not been increased for twelve years; and

WHEREAS, in an effort to increase both the quantity and quality of our substitute pool, it is recommended that we adopt a tiered level of pay for our substitutes; and

WHEREAS, this would include a base rate increase from \$72.00 to \$85.00 daily for generally licensed substitutes; an increase for core (permanent) substitutes from \$80.00 to \$95.00 daily; and a daily rate of \$105.00 for retired teachers and substitutes licensed in education; and

NOW THEREFORE, BE IT RESOLVED, that the Canton City School District Board of Education approves the rate increase for substitutes as follows: base rate increase from \$72.00 to \$85.00 daily for generally licensed substitutes; increase for core (permanent) substitutes from \$80.00 to \$95.00 daily; and a daily rate of \$105.00 for retired teachers and substitutes licensed in education.
