(as a sole source vendor) is willing and able to sell iPads directly to the Canton City School District at a significant discount at a quantity sufficient for all Kindergarten through 3rd grade students to have an iPad on which to participate in distance learning for the 2020-2021 school year; and

WHEREAS, the Assistant Superintendent in charge of the State and Federal Programs has sufficient funds remaining in the 2020 fiscal budget of ESSER funds for the nonpublic school, Our Lady of Peace Elementary School, to make the purchase. These iPads shall be inventoried and labeled as property of the Canton City School District, purchased with ESSER funds and Our Lady of Peace Elementary School is fully aware of these property rights.

THEREFORE, BE IT RESOLVED, that the Canton City School District Board of Education authorizes the Assistant Superintendent in charge of the State and Federal Programs Department to purchase 200 iPads from Apple, Inc. at a total price of \$58,800.00.
