WHEREAS, the Stark County Schools' Council of Governments advertised bids for school buses, and;

WHEREAS, the bids were received on Tuesday, October 11, 2022 and reviewed by the bus

bid review committee for compliance, and;

WHEREAS, Cardinal Bus Sales & Service, Inc. submitted a bid for a 30-passenger school bus with specifications acceptable to Canton City School District, Cardinal Bus Sales & Service, Inc. 30-Passenger Micro-Bird School Bus (as specified) \$84,565.00, and:

WHEREAS, the total cost \$84,565.00 will be funded with funds received from the ESSER, and;

THEREFORE, BE IT RESOLVED the Canton City School District Board of Education hereby authorizes the purchase of one 30-passenger school bus, totaling \$84,565.00, and;

BE IT FURTHER RESOLVED that the Canton City School Board of Education does hereby reject all other bids submitted on this project
