## **RESOLUTION TO CREATE A BOARD POLICY COMMITTEE**

WHEREAS, Effective Board Policies guide the direction of the District, bring about prudent changes, and help protect the District from litigation; and

WHEREAS, Good Board Policy development is aided by input from District stakeholders; and

WHEREAS, District Policy development and evaluation is the duty of the Board of Education and the most important component of District governance; and

WHEREAS, District Policy defines where the District is currently, and directs where the District hopes to be in the future; and

WHEREAS, Committees comprised of Board members, District employees, and community members assure thoughtful Policy development; and

WHEREAS, Committees foster transparency, and promote public trust; and

WHEREAS, Committees are a layer of public engagement and accountability; and

WHEREAS, Committees bring District policy makers up close and personal with the many facets and complexities of the Canton City School District; and

WHEREAS, The Canton City School District faces challenges in academic performance, labor relations, and community confidence; and

WHEREAS, Committees serve to help policy makers be more deliberative, transparent and make better decisions; and

WHERAS, The Ohio School Boards Association recommends review of a District's policy manual *in total* every five (5) years, and the Canton City School District's last review occurred in 2004; and

WHEREAS, The federal Every Student Succeeds Act (ESSA) will result in the need to revise and review many current policies and create new policies; and

WHEREAS, Board Policy BCE reads in pertinent part ... "The Board may authorize the establishment of committees from among its membership as it finds such action necessary to study operations in specific areas and to make recommendations for Board action"; and

NOW THEREFORE, be it resolved, that the Canton City School District creates the Board Policy Committee; and

BE IT FURTHER RESOLVED that the Canton City School District Board Policy Committee be comprised of two (2) Board of Education members, one of whom will act as Chair, superintendent, two (2) community members, at least one of whom is a parent, a principal, and a representative of the Canton Professional Educators Association, and that the Board Committee has the authority to hear testimony from experts on matters before it.

RESOLUTION TO CALL ON STATE LEGISLATURE TO ELIMINATE THE EXTRACTION OF CHARTER SCHOOL TUITION AND FUNDING FROM PUBLIC SCHOOL DISTRICTS AND THEIR TAXPAYERS, AND DIRECTING THE TREASURER TO INVOICE THE OHIO DEPARTMENT OF EDUCATION FOR FUNDS EXTRACTED FROM THE CANTON CITY SCHOOL DISTRICT FOR CHARTER SCHOOLS

WHEREAS, it is the statutory duty of the Canton City School District Board of Education to deliver quality education programs and services to the school children of the Canton City School District, and

WHEREAS, members of the Board of Education are elected by the Canton City School District community to provide an effective, efficient, and productive education to its students, and

WHEREAS, the elected Board of Education is directly responsible to the Canton City School District community, including taxpayers, students, parents, and other patrons, and

WHEREAS, the Charter School Industry, with the assistance of the Ohio Department of Education and others, has taken the sum of \$84,300,355.70 from the Canton City School District, its students, and taxpayers since 2003, and

WHEREAS, the Charter School Industry now extracts about \$1 Billion dollars (\$1,000,000,000) annually from public school districts across the State of Ohio, and

WHEREAS, local school district boards of education have no control of Charter School students, financing, educational programming, student outcomes, and student performance, and

WHEREAS, Charter Schools in Ohio have demonstrated an overall low academic performance compared to public schools (80% of Ohio Charter Schools are performing poorly), and

WHEREAS, the Charter School Industry has created a climate of waste, fraud, abuse, and corruption that is threatening to permeate all branches of government, including the Ohio Department of Education, undermining confidence and trust in our public institutions, and

WHEREAS, the State of Ohio has demonstrated its lack of capacity to effectively monitor and police the Charter School Industry, resulting in the U.S. Department of Education's recent withholding of a \$71 million grant to Ohio, and
