# RESOLUTION TO ENTER INTO SETTLEMENT AND RELEASE AGREEMENT

**WHEREAS**, on March 6, 2018, A.R. filed a lawsuit on behalf of herself and her son, T.M., against the Board in the matter captioned *T.M., et al. v. Canton City School District Board of Education, et. al.* in the United States District Court for Northern District of Ohio, Eastern Division, bearing the Case Number 5:18-cv-00515 (the "Lawsuit");

**WHEREAS,** the Lawsuit also named Canton City School District ("District") employees Adrian Allison and Corey Grubbs, along with former employee Kenneth Weatherbee, as co-defendants with the Board, in their individual and official capacities;

**WHEREAS**, the Board maintains that it, along with Mr. Allison and Mr. Grubbs, has acted in accordance with the law at all times and denies all fault or liability for any damage or claim whatsoever as alleged by A.R. with respect to her or her son, T.M.;

**WHEREAS**, the Board anticipates expending valuable financial resources and personnel time to defend the Lawsuit through trial;

**WHEREAS**, the parties have expressed a willingness to resolve the Lawsuit by way of a settlement, release and waiver agreement, which would enable the avoidance of additional expense and uncertainty arising from trial of the matter; and

**WHEREAS**, an early resolution of the Lawsuit would result in significant cost savings to the Board.

# NOW THEREFORE BE IT RESOLVED:

1. The Board deems it is in the best interests of the District to enter into a settlement, release and waiver agreement and obtain an early resolution of the Lawsuit to avoid unnecessarily expending valuable resources by defending the Board's position through trial.

2. The Board hereby enters into the attached settlement, release and waiver agreement (the "Agreement") to resolve the Lawsuit in accordance with the terms and conditions set forth in the Agreement, which is attached hereto as <u>Attachment A</u> and incorporated herein fully by reference. Although a partially redacted Agreement is attached hereto pursuant to R.C. 3319.321 and 20 USC 1232g, the Board considered and approved the full, unredacted version of the Agreement.

3. The Board directs the Board President, the Treasurer, and/or the Superintendent to execute the attached Agreement on its behalf.

4. The Board authorizes its insurer to process the payment as set forth in the attached Agreement.

5. The Board President, the Treasurer, and the Superintendent are authorized and directed to do all things necessary and consistent with this Resolution and to take such actions as are necessary or appropriate to accomplish the objectives of this Resolution.

6. It is hereby found and determined that all formal actions of this Board concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Board, and that all deliberations of this Board and any of its committees that resulted in such formal action were in meetings open to the public or in executive session as permitted by Ohio law.

7. This Resolution shall take effect and be in force from and after the earliest period allowed by law.

**WHEREAS**, the Canton City School District Board of Education wishes to support the efforts of other boards of education to obtain favorable judicial decisions;
