A RESOLUTION ACCEPTING THE COLLECTIVE BARGAINING AGREEMENT WITH CANTON PROFESSIONAL EDUCATORS' ASSOCIATION

WHEREAS, Ohio Revised Code Section 3313.17 permits the Board to enter into contracts, including those contracts collectively bargained pursuant to Chapter 4117 of the Ohio Revised Code;

WHEREAS, the Board has engaged in collective bargaining with the Canton Professional Educators' Association ("CPEA") during which the parties have come to an agreement; and

WHEREAS, Section 4117.09 requires a collective bargaining agreement to be reduced to writing and executed by all parties.

NOW, THEREFORE, BE IT RESOLVED by the Board:

SECTION 1. That the proposed revisions to the prior Collective Bargaining Agreement between the Board and the CPEA, effective July 1, 2021 through June 30, 2024, attached hereto as Exhibit "A" and incorporated herein fully as if by reference, are hereby accepted and approved for execution on behalf of the Board.

SECTION 2. This Resolution shall take effect and be in force from and after the earliest period allowed by law.

BE IT FURTHER RESOLVED that this Board so charges the Treasurer with carrying out any functions necessary to implement this action.

All formal actions of this Board concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Board, and all deliberations of this Board and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code, unless a lawful exception applies.
