WHEREAS, the Transportation department has determined that the camera surveillance equipment provided by Pro-Vision Solutions has video equipment best suited for the District's school buses and vans,

**WHEREAS**, Ohio Revised Code, Chapter 9.48 permits a political subdivision to participate in a national joint purchasing program, and

**WHEREAS**, identical equipment proposals were received from Pro-Vision Solutions and two cooperative buying groups; Interlocal Purchasing Systems (TIPS) and COSTARS, and

**WHEREAS**, Pro-Vision Solutions provided the most competitive pricing for the required Canton City School District bus fleet equipment, summarized as follows,
