A RESOLUTION AUTHORIZING THE SUPERINTENDENT TO SIGN THE U.S. DEPARTMENT OF EDUCATION'S APRIL 3, 2025 "REQUEST FOR CERTIFICATION" CONCERNING TITLE VI COMPLIANCE

WHEREAS, on April 3, 2025, the U.S. Department of Education ("ED") issued a "Request for Certification" to State Education Agencies ("SEAs") requiring certification of compliance with Title VI of the Civil Rights Act of 1964, its implementing regulations, and Supreme Court cases interpreting the same; and

WHEREAS, the Ohio Department of Education and Workforce has requested that all Local Education Agencies (LEAs") in Ohio complete and submit this certification; and

WHEREAS, the Board of Education fort he Canton City School District ("District") has previously certified its compliance with Title VI of the Civil Rights Act of 1964 and its implementing regulations as part of regular applications for federal funding, and those certifications remain in effect; and

WHEREAS, the District is committed to providing all students with a high-quality education in a safe, supportive, and inclusive environment, regardless of race, color, national origin, or other protected characteristics; and

WHEREAS, the District has been faithfully implementing education programs in accordance with all federal law, including Title VI and other antidiscrimination laws, and will continue to do so; and

WHEREAS, federal education funds provide critical resources for District students, including students with disabilities, English learners, and economically disadvantaged students, and the District wishes to avoid any disruption to these essential programs;

NOW, THEREFORE, BE IT RESOLVED by the Board of Education of the Canton City School District authorizes the Superintendent to sign the U.S. Department of Education's "Request for Certification" concerning Title VI compliance dated April 3, 2025.

BE IT FURTHER RESOLVED that in authorizing this signature, the Board wishes to express the following:

- 1. The District is taking this action primarily to maintain access to federal funding, which the U.S. Department of Education has threatened to withhold from districts that do not sign the certification document;
- The District has repeatedly over th years provided the requisite assurances of its compliance with Title VI and its implementing regulations and other applicable federal laws and intends to continue to do so;
- 3. The District views this certification as consistent with those prior assurances and not as an extension of the Board's legal obligations;
- 4. The District notes that to date, no federal court has extended the holding in Students for Fair Admissions vs. Harvard to public K-12 local educational agencies;

- 5. The District further notes that federal courts have not endorsed the vague and ambiguous pronouncements issued by the ED in general opposition to diversity, equity, and inclusion principles:
- 6. The District observes that the Department has not gone through the requisite rulemaking process under the Administrative Procedure Act to develop regulations regarding this matter that may be entitled to the force of the law;
- 7. The District's execution of this certificate does not constitute agreement with or endorsement of any particular interpretation of Title VI beyond the text of the statute, its implementing regulations, and binding judicial precedent directly applicable to K-12 public education; and
- 8. The District maintains its commitment to creating educational environments where all students feel welcome, valued, and supported in their learning.

BE IT FURTHER RESOLVED that the Board authorizes the Superintendent to take all necessary actions to protect the District's access to federal funding while upholding the District's legal obligations and commitment to serving all students.

BE IT FURTHER RESOLVED that this Resolution shall be forwarded to the Ohio Department of Education and Workforce, along with the signed Certification form.
